The Public Trustee of the Public Trustee Office Kingsway in the county of London W.C. 2

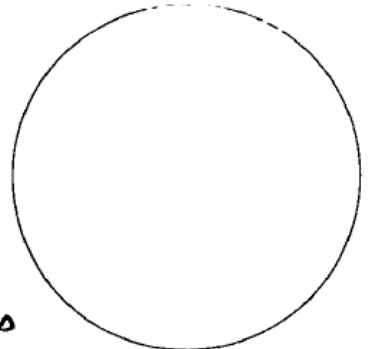
